CANCELLATION:

All orders are subject to acceptance by Anchor Rubber Products, LLC. We reserve the right to cancel any order without advance notice. Purchaser may cancel an order at any time prior to shipment, but will be invoiced for any costs incurred prior to cancellation notice, including but not limited to labor, tooling, or parts costs.

SHIPPING:

CLAIMS:

All claims or shortages must be declared within 30 days after receipt of merchandise, unless otherwise accepted by Anchor Rubber Products, LLC. Defective merchandise must be returned within 30 days of claim. Liability is limited to the invoice value of the defective item. RETURNS:
